The participants were made aware of The POSH Act; Internal Complaints Committee of the college; and were sensitized about the need of appropriate behaviour in the working place. They were apprised of the composition and functioning of ICC. The participants were encouraged to not to tolerate any type of such harassment and report it. At the same time, they were alerted of false reports which can invite to penalisation. The students and faculty members appreciated the program very much.
